(6) REQUEST FOR SUPPORT

a. Township of McKellar - Municipal Amalgamation

WHEREAS the Township of McKellar passed resolution 19-355 regarding Municipal Amalgamation, requesting that before the Provincial Government forces amalgamation in any of the 444 municipalities in Ontario, that the AMO organization goes beyond requesting "consultation" and demand that the Provincial Government do the following:

- 1. Hold a local referendum letting the citizens decide to amalgamate or not.
- 2. Conduct an evidence-based study to show that amalgamation actually saves costs, jobs, lowers taxes and reduces the provincial deficit.
- 3. Allow those municipalities to work out their own local needs and to be permitted to do so on their own time line and volition.
- 4. To ensure that there is absolutely no conflict of interest in this consultative process.
- 5. To emphasize the political reality of forcing amalgamation on the many rural and northern municipalities across Ontario.

NOW THEREFORE BE IT RESOLVED that the Township of Carling supports the Township of McKellar's resolution.

6. MONTHLY REPORTS

The Fire Chief reported that he has been very busy with by-law enforcement. He noted that they are seeing a lot of pressure at some of the access points especially the Dillon site. The Fire Chief reported that he is working on organizing an Emergency Planning session with the area Municipalities. He reported that the fire department has received close to 100 calls which is up from this time last year. He noted that one of his officers is going to be attending a training on drowns at the fire college.

The Planner reported that he has been very busy. He has a number of site plans and minor variances that he has been working on. He also noted that the Youngblood Subdivision is almost completed and the lots are being sold. He is still working on the rezoning of the access points and hopes to bring it forward at the next council meeting.

The Public Works Manager reported that they have received the new truck and that it will be sent to Huntsville this week to get the last parts put on it. He noted that the old truck will be sold. He also noted that they were going to start maintenance on the shoulders of the road to try and increase road safety. He reported that he has started the process of updating the ice rink. Council gave the direction that due to the skill set needed the work to the ice slab will be sole sourced to Black and McDonald along with Quinn. If the work cannot be completed by the fall, the project will be moved until next year and the budgeted funds put into reserves. He noted that he is still waiting to hear back on funding to reconstruct Dillon Road.

The Chief Building Official reported that he has issued 77 building permits and is still receiving a number of inquiries about new builds. He noted that we are busier than we were at this time last year and still have a number of building permit submissions coming in.

The Treasurer reported that she has competed the final grant reporting for the Carling Community Centre. She noted that she has completed the supplemental and write off taxes for 2019. She reported that we have received 89% of the taxes owed for 2019 which is consistent to where we were at this time last year. She reported that she has done training on Municipal Connect and will be meeting with the other treasurers from the area later this week.

The CAO reported that Richard Culverwell has offered to donate a photo to the Carling Community Centre. Council requested that we create a donation policy for the Township before accepting any donations.
